– **[European Council](#)** > [European Council homepage](#)

The European Council defines the general political direction and priorities of the European Union. With the entry into force of the Treaty of Lisbon on 1 December 2009, it became an institution.

The European Council provides the Union with the necessary impetus for its development and defines the general political directions and priorities thereof. It does not exercise legislative functions.

The European Council consists of the Heads of State or Government of the Member States, together with its President and the President of the Commission.

The Council of the EU is the institution representing the member states' governments. Also informally known as the EU Council, it is where national ministers from each EU country meet to adopt laws and coordinate policies.

The Council is an essential EU decision-maker. It negotiates and adopts new EU legislation, adapts it when necessary, and coordinates policies.

The Council of the EU should not be confused with: the [European Council](#) – another EU institution, where EU leaders meet around 4 times a year to discuss the EU's political priorities

The presidency of the Council of the EU rotates among member states every six months. The presidency chairs meetings at all levels: Council, Permanent Representatives Committee and working parties. It puts forward guidelines and draws up the compromises needed for the Council to take decisions.

The European Commission is one of the main institutions of the European Union. It represents and upholds the interests of the EU as a whole. It drafts proposals for new European laws. It manages the day-to-day business of implementing EU policies and spending EU funds.

The 28 Commissioners, one from each EU country, provide the Commission's political leadership during their 5-year term. Each Commissioner is assigned responsibility for specific policy areas by the President.

The President is nominated by the European Council. The Council also appoints the other Commissioners in agreement with the nominated President.

The appointment of all Commissioners, including the President, is subject to the approval of the European Parliament. In office, they remain accountable to Parliament, which has sole power to dismiss the Commission.

JRC-IPTS focuses on five major research fields – knowledge for growth, information society, agriculture and global food security, sustainable production and consumption and economics of climate change, energy and transport. It provides policy makers with tools to prepare and justify policy initiatives and later to evaluate them.

IPTS' role is in the interface between science and policy and carries out – in collaboration with other Directorates-General – cost-benefit analyses of policy options within the context of horizontal societal challenges: employment, environment, competitiveness and security.

CEPS - Centre for European Policy Studies

CERN - European Organization for Nuclear Research

At CERN, the European Organization for Nuclear Research, physicists and engineers are probing the fundamental structure of the universe. They use the world's largest and most complex scientific instruments to study the basic constituents of matter – the fundamental particles. The particles are made to collide together at close to the speed of light. The process gives the physicists clues about how the particles interact, and provides insights into the fundamental laws of nature.

The instruments used at CERN are purpose-built [particle accelerators](#) and [detectors](#). Accelerators boost beams of particles to high energies before the beams are made to collide with each other or with stationary targets. Detectors observe and record the results of these collisions.

Founded in 1954, the CERN laboratory sits astride the Franco-Swiss border near Geneva. It was one of Europe's first joint ventures and now has 21 [member states](#).

EUREKA is an intergovernmental organisation for market-driven industrial R&D. It is a decentralised network facilitating the coordination of national funding on innovation aiming to boost the productivity & competitiveness of European industries. The network integrates over 40 pan-European economies, but also includes Israel, South Korea, and Canada. Following a bottom-up approach with projects being in any technological area with a civilian purpose, EUREKA has been the driving force of innovation in Europe for over 25 years.
